Congratulations on your upcoming wedding! We are so honored that you have chosen MCN Salon to be part of your special day. Our team is passionate about creating a hairstyle that you will love and putting you at ease on the day of your wedding. We will make every effort to ensure that you have an amazing and “Beautiful Hair Day” for your big day!

In order that your day has a smooth start, we have a few simple steps for you to review. Please read thru this contract and fill in the blanks and we will take care of the rest.

As the Bride, you will want to have a pre-wedding consultation/trial appointment scheduled with a stylist of your choice to create and finalize the desired result for your “Wedding Hair”. The trial appointment is necessary so that you and the stylist are completely comfortable and in-sync with how much time it will take and what the final result will be.

The trial appointment is scheduled for 45minutes. The charge is \$75.00 based on a 45 minute appointment. If you desire a longer appointment time to try a variety of styles, the charge will be based on time required. When scheduling, please be sure that you ask for additional time if it needed.

The total cost of your style for the wedding day will be quoted to you at the trial appointment.

Pre-Wedding: Our experienced team members have provided you with the 4 most requested wedding styles, each of which are customizable. You can find these looks on our website. www.mcnsalon.com Please forward our website to your bridal party. Once each of you have selected your desired look, please list everyone's name, their desired selection and preferred stylist, if applicable. We ask that they review and discuss with you the bride the styles that we offer. This will insure that you and your bridesmaids and or family attendees have decided on a style that is suitable for them and that everyone is comfortable and pleased with the end result.

The Big Day: In order to provide you a relaxing experience, we ask that the entire bridal party arrives 15 minutes prior to your scheduled appointment time. Please arrive with clean and dry hair. You are welcome to bring food and drink to get your day started. Let us know ahead of time and we can have a table set up for you and provide you with glasses for your beverage of choice.
